BOARD MEETING MINUTES – DECEMBER 16, 2021

The regularly scheduled meeting of the Village Board of Glasford was convened at 7:00pm. In attendance were Mayor Rudd, Clerk/Treasurer Stetler, Trustees Allen, Sheckler and Kingsley. Trustees Randle, Arnold and Godby, were absent. Also in attendance were Chief Beachler and Heidi Rhea.

Motion for approval of November 18, 2021 board meeting minutes, made by Kingsley, 2nd by Allen. Roll call: ALLEN—AYE; RANDLE—ABSENT; ARNOLD – ABSENT; GODBY—ABSENT; KINGSLEY—AYE; SHECKLER—AYE. Roll call . . . all ayes. Motion carried.

Board recognized Heidi Rhea representing Alpha Park Library. Ms. Rhea informed board of upcoming new programs that would be offered at the library that would benefit the Glasford community. Discussion followed.

STREETS and MAINTENANCE REPORT presented by Trustee Allen due to Reimer's absence.

Trustee Allen informed the Board of engineer's suggestion to resolve the drainage issue on W. Second Street between Barron and Fahnestock Streets. Discussion followed. Work to begin in the Spring of 2022.

Trustee Allen presented John Randle's, 309 E. Oakley St., request of a 20ft culvert extension near southeast corner of property running north from garage. Discussion followed. Mr. Randle to pay for culvert and Village will put the extension in at the desired location.
