

**VILLAGE OF GLASFORD**  
**BOARD MEETING MINUTES – MAY 18, 2023**

The regularly scheduled meeting of the Village Board of Glasford was convened at 7:00pm. In attendance were Mayor Rudd, Clerk/Treasurer Stetler, Trustees Allen, Randle, Arnold, Godby, Sheckler and Kingsley. Trustee Allen was in attendance via telephone conference. Also in attendance were Streets/Maintenance Supt. Reimer; Chief Beachler; John & Nanette Rudd; Zach & Tammie Swonger; and Donita Sheckler.

**RECOGNITION OF VISITORS**

READING and APPROVAL of April 20, 2023 board meeting minutes. Motion to approve April 20, 2023 minutes made by Kingsley, 2nd by Sheckler. Roll call: ALLEN—AYE; RANDLE—AYE; ARNOLD –AYE; GODBY-AYE; KINGSLEY—AYE; SHECKLER—AYE. All ayes, motion carried.

Zach Swonger discussed with the Board his plans for 501B S. Poplar Street. Discussion followed. Swonger was informed that the house cannot be lived in at this time; the roof has to have new shingles installed; all open windows or doors must be boarded up; and steps installed for back door. Also, he is to attend July 20, 2023 to what progress has been made on the rehab of the house.

Nanette Rudd requested that for future motorcycle events, Main Street be blocked off from Saylor St. to Glasford Road as it is done for the annual car show. Board approved the request.
